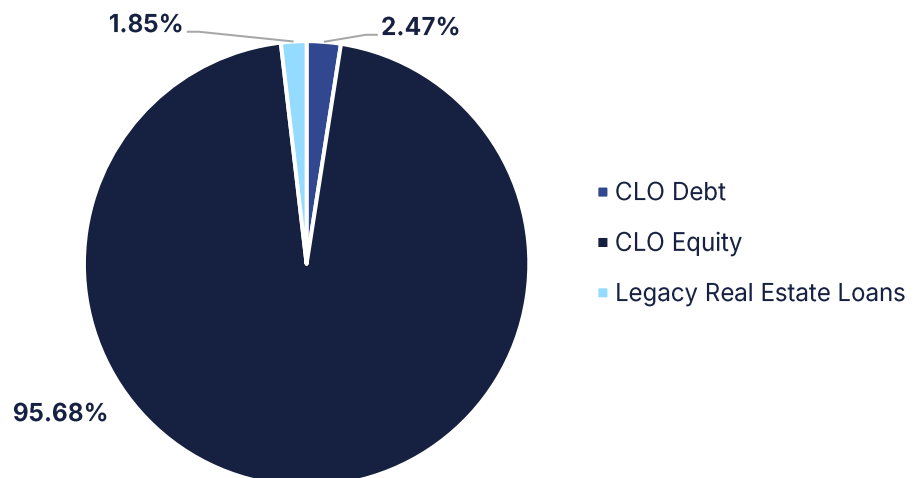

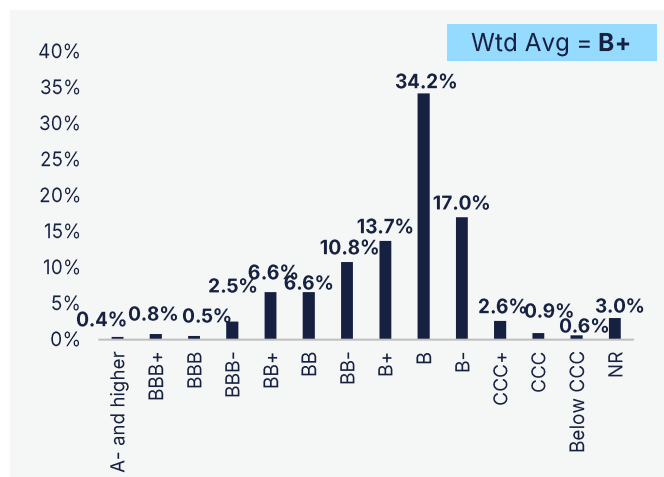

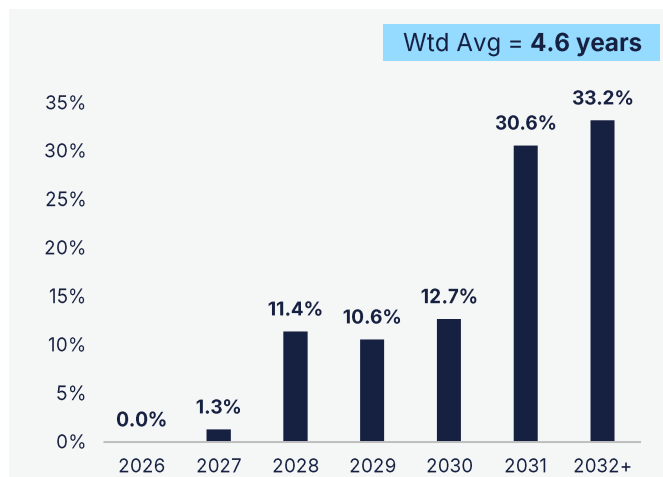

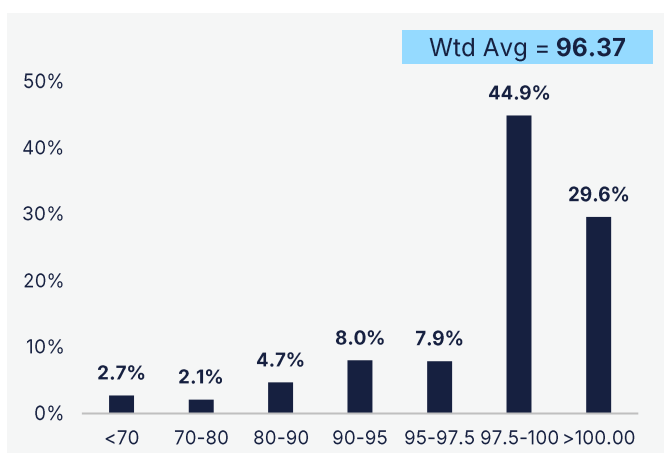
Weighted average rating distribution¹



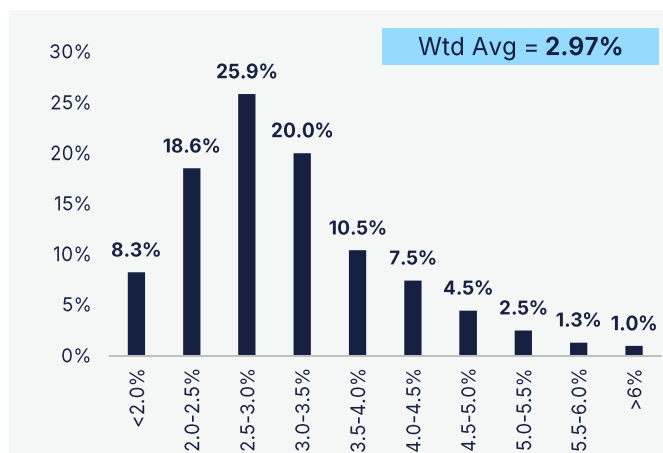
Weighted average maturity distribution¹
