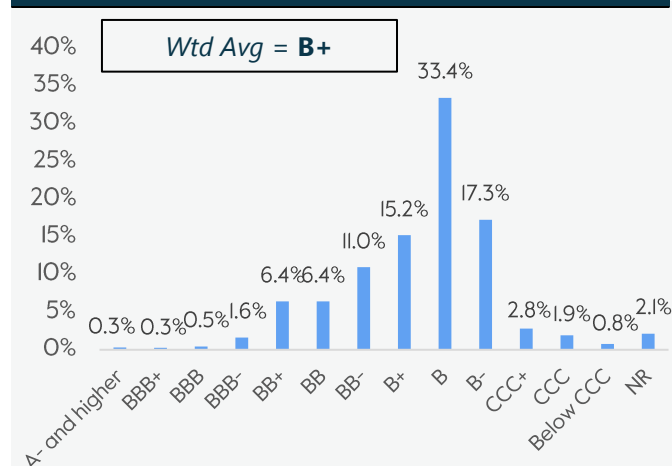

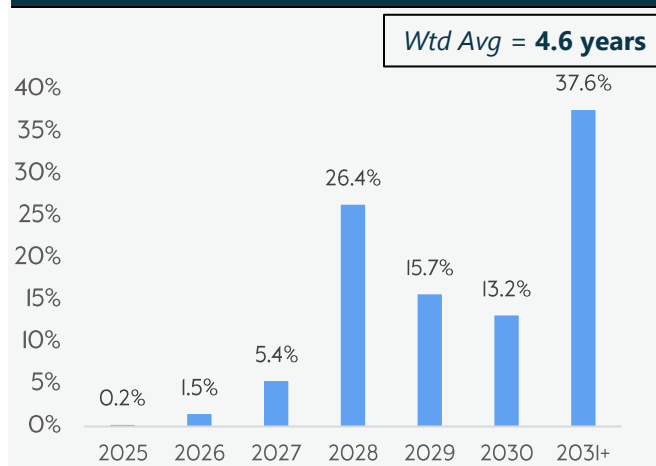

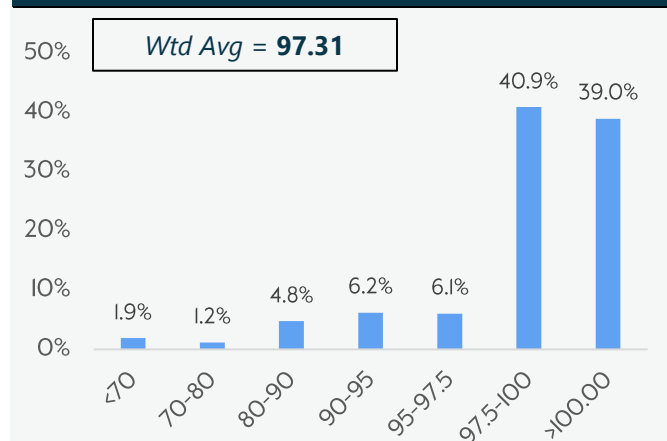
WEIGHTED AVERAGE RATING DISTRIBUTION¹



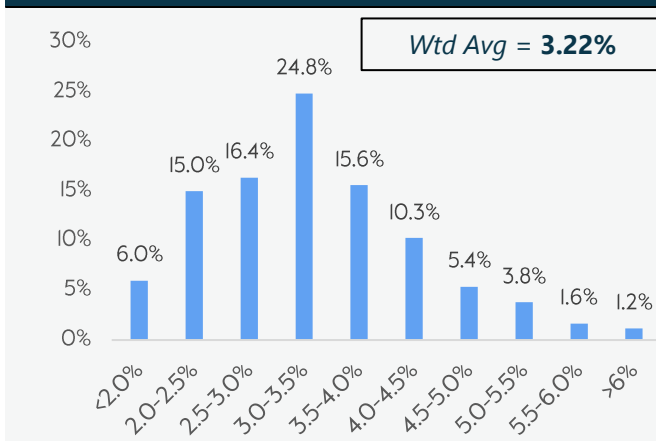
WEIGHTED AVERAGE MATURITY DISTRIBUTION¹
